
















### Steps to get funded




We review the financial statements from the past two years. To proceed the risk score should be ≥4 (C+). The process takes 1-3 days. Fill the online form and submit the company's Registration Proof, Articles of Association, Identity Proof of the Legal Rep. and a Shareholder Declaration. This process should take 1-2 days.

We will help write your story and present your project as an investment opportunity to a large community.

Your project will be shown on our platform and promoted through social media and traditional media. Money to wallet usually takes 10 days.

### Stages to get funded:



### 1. Information request:

#### Documents needed for a risk analysis:

- Official financial statements from the past 2 years (Balance Sheet + P&L)
- Provisional financial statement from the current year
- Business plan with financial projection for the next 3 years
- Pitch deck
- Fiscal Identification Number
- Project description and backup documentation
- Desired financial conditions:
  - Amount
  - Maturity
  - Grace period (if needed/applicable)

# 2. Account creation and background:

#### Documents needed to open an account:

- Registration Proof
- Articles of Association
- ID of the Legal Representative
- Shareholder Declaration

#### **Background check:**

- Declaration of no debt to the Social Security
- Declaration of no debt to the Tax Authority
- Debt report from the Central Bank
- Criminal record of the organization
- IBAN certificate
